The Director, Animal Husbandry & Veterinary Department, Mizoram, Aizawl on behalf of the Governor of Mizoram invites Expression of Interest from individuals/firms having 2 acres of land available for establishment of works under the project entitled **"Sustainable Animal Feed Distribution System to Check Inflation of Meat and its End Product at Sairang/Lengpui: Mizoram (and including the surrounding areas upto 10 Km radius from the proposed Rail Station at Sihhmui)"** with an estimated amount of Rs. 4,65,00,000/- (Rupees Four Cores Sixty Five Lakh) only. ## Background

The Department of Animal Husbandry & Veterinary, Govt. of Mizoram intends to initiate sustainable animal feed distribution system to check inflation of meat and its end product.

The project aimed to decrease the finished product of livestock and poultry feed by minimising the huge transportation cost incurred during road transportation. The main goal is to procure ingredients of feeds as well as finished products from the mainland India by using railway transport to lower the transportation cost. This will bring down the cost of per kilogram of finished product feed which will subsequently reduce the end product of meat and its end product.

## Aims & Objectives

1. To Provide a channel for lower animal feed cost to the farmers for decreased in lower cost of end product.
2. Ensure availability of Nutrient rich feeds for Livestock & Poultry throughout the year at lower cost.
3. Creation of Animal Feed Go-down chain at Rail-head in Sairang/Lengpui to reduce procurement cost.
4. Procurement of Animal Feeds at larger scale from main manufacturer Industry/ Company.

## Eligibility

1. The applicant should have a minimum of 2 acres of land within 10 Km radius from the proposed Rail Station at Sihhmui with proof of land ownership such as Periodic Pata/ House Pass/LSC issued by Land and Revenue Department.
2. The applicant should submit in his own words his willingness to offer the land for establishment of the project in stamp paper of Rs. 100/- with a valid notary registration.



## **Scope of Land Offer**

1. Preference will be given to the owner of the land offered for running the business.
2. The lock in period of donating the land will be 9 (nine) years.
3. All assets will be handover to the land owner at the end of the lock in period given that the business had been successfully operated within the said period.

2. Proof of owning of land (refer to eligibility)
3. Willingness to offer land for the project (Rs. 100/- stamp paper).
4. Attested copies of Aadhaar / PAN / GST registration/ Voter's ID
