### **INSTRUCTIONS TO BIDDERS (ITB)**

### **1. GENERAL INSTRUCTIONS:**

- 1. The bidders are required to go through the tender document thoroughly and to ensure compliance of all the instructions herein. Non-compliance of the instructions contained in this document may disqualify the bidders from the tender process.
- ii. Tender should be submitted in one big sealed envelope duly superscribed on the cover with "**Supply of Equipments for Cold Chain under NADCP**" and addressed to:

Animal Husbandry & Veterinary

Khatla: Aizawl

iii. The sealed envelope should contain 3 sealed envelopes marked **A**, **B**, **& C** as prescribed below:

a. **Envelope A** containing duly filled up and signed Application form as per the proforma, given at **Annexure-1** enclosing valid up-to-date Tax clearance certificate, duly attested Photostat copies of valid GST registration and PAN certificate and Tender fee receipt of Rs. 1500/- as well as Earnest Money Deposit (EMD) of Rs. 1,20,000/-, in the form of Demand Draft in favour of Director, Animal Husbandry & Veterinary, Govt. of Mizoram.

- b. **Envelope B** containing the Technical Bid along with the supporting documents (Annexure 2&3)
- c. **Envelope C** containing the Financial Bid (Annexure 4) along with supporting documents.
- iv. Bidders may submit tender through registered post or by dropping in the Tender Box, placed at the office of Livestock Health Section, Directorate of Animal Husbandry & Veterinary, Khatla, Aizawl. Tenders not in proper sealed cover or received telegraphically/E-mail/Fax will not be entertained
- v. The Bid shall be treated as a 2 Bid System. The Technical Bid will be considered for applicants whose Tender Fee, Earnest Money Deposit (EMD) and other documents enclosed with Application form (Annexure-1) are found in order. The bid shall be opened on 18<sup>th</sup> Oct 2023 at 1:00 P.M. at the Directorate Committee Room, A.H & Vety, Khatla in presence of the bidders or their representatives who desire to be present.
- vi. Tender Fee is non-refundable.
- vii. The bid and all the related correspondences and documents must be written in English Language.
- viii. Bids which do not fulfill all the criteria prescribed in the ITB shall be rejected summarily.
- ix. All pages of the tender should be signed, stamped and dated. Corrections if any, should be made clear without overwriting and should be initialed. Note that the tender document is subjected to verification with the original document and if any discrepancy is found, the tender would be rejected.

## 3. QUALIFICATION OF A BIDDER

- i. A bidder must be the owner of a reliable company or its authorised dealers/distributors/suppliers dealing with the items for which bid is submitted.
- ii. All Bidders should submit the following information and documents along with their bids:
  - a. GST Registration Certificate for tenderer firm.
  - b. Photocopy of dealership Certificate/Authorisation letter
  - c. The Samples or brochures/catalogue should be submitted along with the tender.

### 4. BID PRICE

- i. The contract shall be for a period of 60 days from the date of issue of supply order.
- ii. All duties, taxes, royalties and other levies payable by the bidder under the contract, or for any other cause, shall be included in the rates, prices, and total bid price submitted by the bidder.
- iii. The rates and prices quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment.
- iv. All rates/prices quoted should be FOR destination.

### 5. EARNEST MONEY

- The bidder shall furnish, as part of the bid, Earnest Money of R s 1,20,000 ( Rupees One lakh and Twenty Thousand)Only the form of **Demand Draft** in favour of the Director of Animal Husbandry & Veterinary, Govt of Mizoram. The Demand Draft shall be payable at Aizawl and valid for at least 3 months.
- ii. Earnest Money Deposit in respect of the unsuccessful bidder will be released after selection is finalized. Selected Firm must supply the materials within the specified time, failing which the Earnest money will be forfeited along with cancellation of supply order. EMD shall be returned without any interest within one month of the successful installation and commissioning of the supplied items.
- iii. The Earnest Money of successful bidder may be used as part of Performance Security.
- iv. The Earnest Money Deposit shall be forfeited
  - d. In case a bidder withdraws its bids after opening of Technical Bid and before the expiry of the validity period of the Bid.
  - e. If bidder fails to deposit performance security within specified period asper intimation/ request from the Department.
  - f. If the bidder fails to execute the agreement within specified time as intimated/ requested.

### 6. TECHNICAL BID:

- i. Technical bid should be submitted using prescribed Bid Format (Technical Bid) enclosed **Annexure 2**.
- Details of firm/company along with copy of registrations must be enclosed. In case of authorized dealers/distributor/supplier, certificate in prescribed format enclosed (Annexure 3) from Original Equipment Manufacturers (OEM), on the same should be enclosed for participation in the said tender. Other documents such as performance certificates from clients, experiences, list of users etc., if any, may be enclosed.
   Note: Original Certificates should be produced at the time of opening of the tenders, if demanded
- iii. It must be kept in mind that merely copying the specifications in the tender or merely stating 'specifications as per Tender document' shall not be entertained. The product specifications must be supported by the printed technical leaflet/literature of the quoted model of the item and list of users.
- iv. Installation and Commissioning: The delivery, installation and commissioning of the instruments is the entire responsibility of the supplier. The items should be delivered to the Director, Animal Husbandry & Veterinary, Khatla, Aizawl,
  Mizoram-796001. Installation should be completed within next 60 days of receiving of items by the procuring authority. The installation and commissioning should be free of cost. Otherwise the warranty period will be extended proportionally.

#### v. After sale service:

After sales service is most important and taken into consideration for evaluating and comparing bids. After sales service/maintenance capability, mitigation of risks or breakdown and replacement capability and nearest sales and support service centres and their plan to address issues about services, maintaining minimum service inventory etc. offered by the manufacturing company must be submitted by the Bidder.

#### vi. Warranty:

Warranty period for instrument quoted should be indicated which should not be less than twelve months from the date of successful commissioning of the instrument. During the warranty period, replacement of any part of equipment's or rectification of defects of works will be free of cost.

#### 7. FINANCIAL BID:

- Price bid should be submitted using prescribed Bid Format (Financial Bid)
   enclosed at Annexure-4 and prices should be clearly quoted in terms of Indian
   Rupees, in figures as well as in words.
- ii. The prices must be quoted item-wise, that is, basic price, taxes, duties, installation, packing, freight and other charges.
- iii. The quoted price should be F.O.R Mizoram.
- iv. The quoted rates must be valid for 60 days from the date of submission of the tender.

#### 8. BID OPENING

- The envelope containing the Technical Bid received within the stipulated time will be opened in the presence of the Bidders/Bidders' representatives who chose to attend at the time, date and place and time mentioned.
- ii. The Bidders' names and such other details as the Department may consider appropriate, including availability of Earnest Money, documents enclosed and their validity shall be announced at the time of opening.
- iii. Evaluation of Bids with respect to Bid Security, Qualification information and other information shall be taken up immediately.

iv. The Undersigned is not bound to accept the lowest rate or any of the tenders and reserved the rights to accept or reject any tender without assigning any reason thereof. A combination of cost and Quality will be considered for evaluation.

#### 9. PERFORMANCE SECURITY

- i. Successful bidder will have to deposit 3% of the total bid/contract value as performance security in the form of Bank Guarantee/ Demand Draft in favour of Director, Animal Husbandry & Veterinary, Government of Mizoram payable at Aizawl before award of the work. The performance security will be refunded only after the expiry of the contract as specified in the bid document/agreement.
- ii. The performance security deposit shall be forfeited in case any terms and conditions of the contract/agreement, etc. are infringed or the bidder fails to complete the supply in time.

#### 10. PAYMENT:

Full payment will be released after complete installation and commisioning of the instruments, to be certified by Director, Animal Husbandry & Veterinary,Mizoram on submission of bills in duplicates. There shall be no advance payment and no such request shall be entertained.

#### **11. OTHER TERMS & CONDITIONS**

i. The Animal Husbandry & Veterinary, Government of Mizoram reserves the right to postpone or cancel the bid, and the bidders will have to abide by such decision topostpone or cancel the bid process.

- ii. Quotation may be submitted on the printed letter head of the bidder.
- iii. If the supplied item is found defective or unsatisfactory or fall short of the specifications in the purchase order, the same will be replaced at the supplier's risk and cost. No freight and other charges for replacement will be paid by the Board.
- iv. The Department has the power to revoke the supply order for unsatisfactory performance or for any other reason any time during the contract.
