Editorial ASF (African Swine Fever) chuan ziaawm lam a pan hleithei ta vak lo a, nikum aṭangin a thawh thumna (3rd wave) a lo lang leh ṭan a, tunah chuan kan State-in kan buaipui leh ta viau a ni, chuvangin ASF laka kan invenna atana vaccine ṭha a la awm bawk si lovah chuan, hma kan lo lâk ve theihna pawimawh ber chu Bio-Security tih ṭhat hi a ni a, World Organization for Animal Health (OIE) chuan Bio Security chu Ran hri leng laka kan ran vulhte vêng tura hma kan lâk theih pawimawh ber tiin. A sawifiah dan chuan "Ran inkara hri inkaidarh theihna tur kan tihtlem leh a vânana kan ran vulh dana hma laknate" a ti a. Heng Bio security kan tih zingah hian langsar leh pawimawh ber ni thei chu Fencing (pal hung) hi a ni a, Fencing ṭha taka siam chuan ran damlo leh mihringin a duh duha a kal tlang theihna lakah kan ranvulhte kan vêng dawn a ni. Kan ran vulhte chu an awmna bik kan siamsak ang a, mihring awmna/chêt tlatna nen a inhlat thei ang ber ni se la, chung hmun te chu inkalpawh zung zung theih loh nan hung ngei tur a ni. Kan in bul hnaia ran kan vulh (Backyard Farming) te pawh hi a nihna takah chuan hri laka ven an harsa a ni. Heng bakah hian ran in luh hma, gate-ah damdawia pheikhawk chiahna (foot bath) te siam ṭhin tur a ni a, hengah hian tui sen (Potassium permanganate) te pawh a hman theih a, Farm lian deuhah phei chuan pawn lam mi luh dawnin in bualna siam ṭhin a ni. Farm-a lüt turte chu an inbual faitir vek hnuah thawmhnhaw fai Farm chhunga a hâk tur bika siamte an haktir a, Boot thianghlim an buntir ṭhin bawk a ni. Face mask, gloves leh hair cover etc te pawh an hmang ṭhin bawk. Savaten natna hrik an put kual ve theih ṭhin avangin Farm ṭhenkhat chuan an ran in te net-in an zar hliah ve ṭhin bawk. Chuvangin ASF lêng darh zêlna turah hian vawk vulhtute pawhin tih theih kan nei ṭeuh a. Heng Bio Security tih dan kan sawi ṭhenkhatte hi ṭha taka kan zawm chuan ASF lêng tur lakah nasa takin kan vawkte kan lo vêng ve thei dawn a ni.

Signal Grass hi ran tana chaw ṭha leh pai ṭawih nuam tak, Bawng, Sial, Lawi leh ran dang tan pawha chaw ṭha leh an duh em em mai a ni a. Mizoram hian a ṭha duh hle a, AH & Vety Department hma lagnain Mizoram hmun hrang hrangah chin darh a ni, chin ṭan kumin kum khatah vawi 2 cut a tling hman a, a kumhlun hnu chuan vawi 4-5 a cut theih a ni.

A chin dan tlangpui:

1. Seed (A chi tuh) : A chinna tur hmun kha duhthusam chuan leh phut ngei a ṭha a, a harsat erawh chuan kangvarah buh tuh angin tuh theih a ni. Bi khatah a chi 5-8 vel 1'-1½' kar danah

tuh mai tur a ni. A chi hi Acre 1-ah 2-2.5kg vel a tawka ngaih a ni. Lei ṭha Urea emaw Bawng ek emaw pêk tur a ni a, Urea hi Acre 1-ah Quintal 1 a tâwk vel a, duhthusam-ah chuan a bi bul tinah phul ni se Urea pawh a hek lo deuh.

Grass chu a lo ṭiak a 4" vel a lo nih chuan a bula hnim dangte chu thlawh fai tur a ni a, a hnu lamah chuan amah hian hnim dangte chu a dip ral tawh mai a ni. Chin ṭan kum hian August/September vel-ah a cut ṭan theih a ni.

2. A bul phun (Root Stump/ Slip) : Hei hi a bul kara phun leh a ṭiak phun sawn a ni. Phunna tur kha sam faia hal hnuah khur ½' vela zau 1'-1½' dan-ah laih tur a ni. Tah chuan lei ṭha nen lei chawhpawl tur khur khatah hian bul (root slip 5-

8 vel zel phun tur a ni. Phun hunah hian ruah tui a awm chuan May thla hi duhthusam ber a ni a, June thla pawh a pawi lo phun kum hian vawi 3 cut a tling hman thei, ram hectare 1-ah hian Root Slip/Root stump 50,000-70,000 vel phun theih a ni.

Gongo Signal Grass hi a kum lehah a hrana chin/ phun a ngai tawh hran lova, hmun thawl lai deuhah tihbelh mai tur a ni, ram leilung tha lo leh bua deuhah pawh ngun tak a chin chuan a tha duh hle a, chuvangin ram awitlân deuh leichhe hmunah pawh hlawhtling takin a thar theih a ni.

Congo Signal thatnate:

1. Pai ṭawih nuam tak a ni a, ranin an ei za zelah 50% - 80% pai ṭawih ang an ni


(50 - 80 % total digestibility).

2. Signal Grass hian chaw tha tam tak protein (tihrawl siamtu), vitamin leh mineral chi hrang hrang, a bikin calcium leh phosphorus te a pai tam. Heng mineral calcium, phosphorus leh nitrogen te a pai that avang hian bawngpuiah milk fever a titlem nia hriat a ni.

3. Ram lei that lohna hmunah pawh heng signal grass te hi tha taka chin theih an ni.

4. Ran ei sen loh kan lo thar a nih pawn dah ro (Hay) a vawn that theih a ni a, hei hi bawng chaw tha tak hnim hring awm loh hnuah a la tling a ni.

5. Signal grass chawrno hi vawk leh ar tan pawh chaw tha a tling a ni.



**AFRICAN SWINE FEVER (ASF) AVANGA VAWK THI
RUANG SAWNGBAWL DAN LEH PHUM DAN**

1. Khur thuk taka laih tur.
2. Chinaiin vawk ruang phul/leih leh tur.
3. Leivunga chhilh leh hnuah, a chung lângah chinai bawkin khuh leh tur.
4. A ruang sawngebawltuin shoe cover leh gloves a bun tur a ni.
5. Shoe cover leh gloves te hi khur chhunga phum tel tur. Chumi hnuah kut fai taka sil tur a ni.
6. Ruang phurhna motor emaw ruang zâwnna hmanrua disinfectant or sahbona tihfai thin tur.
7. Disinfectant hman turte:
 - a) 2% Calcium Hydroxide (Chinai)
 - b) 2% Sodium Hydroxide Caustic Soda)
 - c) Detergent (Sahbon – Surf, Mr. White, Tide etc...)
 - d) Phenol Substitute.
 - e) 2-3% Sodium or Calcium Hypochlorite (bleach leh bleaching powder)
 - f) Iodine Compounds.



SIAL TOBUL (THE ORIGIN OF MITHUN)

Mizo ranvulh zinga pawimawh em em pakhat chu sial hi a ni. Kan pi pute hun lai khan mi hausa tehna chu sial ngah leh ngah lohah a ni deuh ber ti ila kan sawi sual awm lo ve. Nupui man atan te an hmang ṭhin a, se chhun leh khuangchawi ni bâkah thil dang tam takah sial hi an lo hmang ṭangkai em em ṭhin. Liandova te unau thawnthu aṭang han hman lai kan pi leh pute nunah sial vulhin awmzia a neih thui dan chu kan hre thei awm e.

Sial hi bawng lam chi chhungkua Bovidae an tih zinga tel niin a scientific name chu Bos frontalis a ni a. Hmun sâng deuh, tuipui zawl aṭanga metre 3000 vel bâwra sângah an cheng ber. A puitling hi 400-600 Kg vela rit a ni thei a, a note piang hlim hi 20 Kg vel

bawr a ni tlangpui. Ran mawi tak niin a lu hi kil thum (a hmui leh a ki pahnih) nei ang deuhin a awm a. A ki hi pawn lamah a chhuak zawngin a ṭo a, a mawi hle bawk. A rawng hi a dum lam a niin a ngal zawn hi a var tlangpui a, a tuipal var te an ti ṭhin; sial râng te pawh a awm ve bawk. Bawng angin a nghawng hnuai lamah irfual (Dewlap) hlai vak lo neiin a dârah erawh thlukvum aiah tihrawl chhah tak a nei thung. Sial hian ramhnuaih an hun tam ber an hmang chung hian ran zaidam tak an ni a. A khât tawka a neituten chi an liah (pe) ṭhin vang hian mihring lakah an zaidam te pawh a ni thei awm e.

Khawvel pumah hian sial hi Asia khawmualpuiah

chauh hmuh a ni a. India ramah hian hmarchhak state pali heng Mizoram, Manipur, Nagaland leh Arunachal Pradesh-ah te chiah hian sial a awm a. Sial hi chi (strain) liah then niin an awmna state ʈheuh hming an chawi hlawm a. Kan ʈhenawm ram ʈhenkhat China, Bangladesh, Myanmar, Bhutan leh Thailand velah te pawh hmuh tur a awm nia sawi a ni. Sial ʈobul hi chiang taka sawi a har hle mai a. Ngaihdan chi thum a awm thei a, chungte chu:

1. Ramsial/Sele (Gaur) thlah dik tak a niang: He ngaihdanah neitute chuan sial (*Bos frontalis*) hi mihringin Sele (*Bos gaurus*) an khawi thlah kal zel aṭanga lo piang chhuak niin an ngai a. Sele nen hian inanna tam tak a nei a, a pawmawm thawkhat viau. Amaherawhchu, sele hi India ram bakah khawvel hmun dangah te pawh a awm nual si a, chung

ramah te chuan sial a awm vek si lo. A mi chengten an khawi ngam ve lo han ti dawn ila bawng leh lawi te an lo khawi ngamin an lo vulh ve fur tho si.

2. Sele leh bawng thlah pawlh aṭanga lo piang a ni ang: Hemi ngaihdanah hi chuan Sial hi Sele leh bawng (*Bos indicus*) thlah pawlh (hybrid) a nih rin a ni a. Mahse, mak deuh chu India ram state dang, sele awm venaah pawh bawng a tam a, sial a awm chuang si lo.

3. Ram bawng chi khat mang (Extinct) tawh thlah a ni ang: Hemi ngaihdan neitute ve thung chuan tun hmaa awm ʈhin, bawng lam chi tho, tuna mang tawh thlah niin an ngai. Ngaihdan pakhatna ang deuh khian mihringten an khawi ngamho thlah lo kal zel aṭanga sial hi lo piang chhuak ta niin an ngai a. Amaherawhchu, a thlahtu tur awm ang han sawi mai tur hriat a ni bawk si lo.

Khing ngaihdan hlawn thum zingah khian a eng emaw ber khi chu a dik ngeiin a rinawm a. Kum 2013 khan Baig-a leh a hoten mitochondrial DNA aṭāṅga an lo zir chianna an tlangzarhah chuan Sial thlahtu hi Sele ni lovin ram bawng chi hran, tuna mang tawh niin an pawm a. Sele leh bawng thlahpawlh chungchang erawh chu zir chianna mumal a la awm lo a nih hmel.

Kum 2017-a Lung-zarhtum khuaa Sele lo tla lut khan bawng (*Bos indicus*) lakah chi a thlah nia sawi a awm a. A thlalak te pawh social media lamah te hmuh theiha tarlan a ni a. Hei hi sial lo chhuah dan ṭobul zirna chungchangah nasa takin a ḫangkai a rinawm a. Mizo zingah mi thiām tam takte hī sawrkar pawhin a chhawr ḫangkai

dan thiām se la, vai leh saphovin research paper tha tak tak ziak nan kan ran leh ramsate hi min hmansak i phal bik lo ang u. Sial ṭobul ngaihdan pahnihna khi a dik rēng em tih pawh hunin a la hril zel turah ngai ang.

Eng pawh nise, India hmarchhaka sial awmna state pali zingah Mizoram kan tel ve hi Pathian malsawmna ropui tak a ni. Amaherawhchu, heng state pali zingah hian Mizoram-ah sial a tlem fâl hle a, an mang lo chauh a ni ber e. Hetiang ran mawi leh zaidam, Mizo hnam ziaa hmun pawimawh tak lúahtu, khawvel hmun tlem tēah chauh awm lehngthal kan lo nei ve hi a lawmawmin a hlu a. A mang mai loh nana hum-halh hi a Mizo hnam pum pui mawphurhna a ni.




