Mihringte nena hnai taka cheng leh inzawmna nei ran leh ramsate'n dinhmun tha , chanvo tha zawk leh dikna an chanve theihna tura hma latu, pawl leh mimal thaahnemngai an lo awm chho ve zel hian ANIMAL WELFARE CHUNGCHANG ngaihven a hlawh phah ve em em a ni. Kan khawvel leh khawtlang nun changkang chho zelin a ken telte pawh kan ti thei awm e. Animal Welfare hi lo belchiang dawn ila, a thil tum te, a pawimawhna leh kan rama animal welfare hnuiaia dan hrang hrang kan neihte hi chiang zawkin sawi kan tum dawn a ni.

Animal Welfare awmzia?

A hmasain ANIMAL kan tih hian rannung emaw, ramsa emaw ran vulh sawina a ni mai awm e.

Ran natna leh hriselna lama hma latu pawl pawimawh tak, WHO tlukpui, OIE (Organization International Epizootics) chuan Animal Welfare hi ti

hian a hrilhfiah a ni – "Ran, ramsa leh thil nung dangte hrehawm lova hrisel leh thlamuang taka an khawsak theihna tura hamthatna leh an chanvo siamsak hi a ni" tiin. Animal Welfare-in a ngaih pawimawh em em chu zalenna panga tia a duan "FIVE FREEDOM"-te hi an ni, chungte chu-

1. Riltam leh tuihalna ata zalenna.
2. Hrehawm taka enkawlna ata zalenna.
3. Natna, Damlohnna leh na tawrhna ata zalenna.
4. An nunphung leh ze pangngai anga awm thei tura zalenna.
5. Hlauhna leh manganna ata zalenna.

Heng kan han sawi tak zalenna panga (five freedom) a lo duan hi rante leh thil nung zawng zawng -ten an chan vek theih hi Animal Welfare -in a tum laimu kan ti thei awm e.

thin. Hei hian rante chungah tul lova hrehawm -na leh tawrhna a thlen NASA thin em em a, an chanvo leh dikna pek hi animal welfare pawimawhna leh a thil tum ber a ni.

1. The prevention of cruelty to Animals Acts (PCA) Act 1960 :

He dan hi Rante chunga tul lo taka natna leh tawrhna a thlen loh na tur

atana siam a ni. He act hnuiah hian Nunrawnna lak ata ran hum halhna dan awm sate pawh siam that a ni bawk. PCA Act hnuiah hian dante hrang hrang 18 lai a awm leh a, a mal malin kan sawi vek lo ang a, a pawimawh zualte chu-Animal Birth Control (dogs) Rules, 2001 and Its Amendments Rules 2010 Dog Breeding and Marketing Rules, 2017 Transport of Animals Rules, 1978 and Its Amendments Rules, 2009 PCA Act hian ran nghaisak, sawisak leh thah te, intihhlimna atana insualtir te, ṭul lo taka natna leh tawrhna tlentir te, hrehawm taka ran phurh te, hrui leh chain-a phuar beh te, mahni ran vulh kutthlak mai leh ṭul lova hliam tuartir te, enkawl duh loa tuithlar te, an ei tur leh enkawlna pe duh lo te, tin, hur sualna lam hawi zawnga chet late pawisa

Section 378: A neitu phalna lova ran in ruksak te hremna dan a ni.

Mizoramah hian kum 2018 August ni 10 khan Mizoram State Animal Welfare Board chu Honble Minister Animal Husbandry & Veterinary Department Chairman-na hnuaiyah din niin Board member 15 dangte ruat an ni bawk. Director, AH & Vety chu Member Secretary ni lai mek a ni. Mizoram District tin ah District Animal Welfare Board chu District Deputy Commissioner te kaihruaina hnuaiyah din a ni tawh a ni.

Mizoram State Animal Welfare Board Hmalak tawhna leh an hmalak mekna te han tarlang ila:

1. Ui talh leh zawrh chungchang

'The Mizoram Animal Slaughter (Amendment) Act, 2020 Section 2 clause (a) leh Food Safety and Standards (Food Products and Food Additives) Regulation, 2011 (2.5.1) te chuan uisa hi mihring ei atana ran talh phalte zingah a telh lo a, heti chung hian Mizoramah mi ṭhahnem takin uisa an eiin an zuar a, uisa dawrah te ualau taka sign board tar thin a ni, hei hi Mizoram State Animal Welfare Board chuan ṭha a ti lova ngennate pek an ni. Tun dinhmunah ui talh leh a sa ei hi khap bur theih ni rih ni lo mah se, tun aia a ziaawm theih nan inzirtirna awareness mipuite zingah leh uisaa sumdawngte hnenah peka hma lak ṭan a ni. Tin kan ram hruaitute - Minister, MLA, Department

leh Kohhran hrang hrangte hnenah an thil tiikhawm neihna hmun leh chaw ei khawmna hmunah te ui talh leh a sa ei khapna dan hi zahsak turin ngenna pek an ni.

Dog Breeding And Marketing Rules 2017 chuan phalna nei lo tan ui inthlah puntir leh ui notea sumdawn hi khap tlat a ni.

3. Dog breeding and Marketing rules 2017-in a phut angin Provisional Licence and Registration for Pet Shop, Dog breeding and marketing chu ui inthlah puntir leh ui notea

sumdawng te tan *dil theih turin peih a ni*. Professional Licence dil te chu Mizoram state Animal Welfare Board-in uluk taka a endik hnuah screening te an paltlang vek hnuah chauh ui inthlah puntir leh ui notea sumdawn phalna Provisional Licence leh Registration te hi pek chhuah chauh thin a ni. Ui breeder zingah pawh Dan ang thlapa Licence leh Registration neite tan chauh ui inthlah puntir leh ui notea sumdawn hi phalsak a ni. Dog Breeding and Marketing Rules te kengkawh tur hian Sorkar leh Private Vety doctor-te chu mawhphurhunna pek an ni.

4. Rante chunga nunrawnna leh hleilenna thleng thin ven nan nasa lehzuala electronic leh print media hmang tea mipui hnena zirtirna awareness campaign buatsaih tura hma lak a ni. Law Enforcement team-te nen Cruelty to Animal Act 1960 hnuia ran venhimna dan awmte hi zir hona nei

tura hma lak a ni. Tin, Director General of police Mizoram hnena rante chunga nunrawnna thleng thin ngaituah tura District Headquarter tinah a police officer pakhat theuh ruat tura ngenna pek a ni.

5. Ran, a bikin ui leh zawhteah tihdudahna, nghaisakna leh hleilenna thleng thin hi action lak zung zung a nih theih nan A.H & Vety call centre No" 1962" chu hman tan a ni. Nunrawnna laka ran chhanchhuah te JB Foundation Shelter Home-a dah mekte chu inkaih-hruaina leh ruahmanna fel tak Mizoram Animal Welfare Board chuan siam-sakin mimal tlawmngaita hnena adoption turin phalna peksak an ni.

6. The Transport of Animals Rules bawhchhiatna hi Mizoram chhungah a nasa tih hriat a ni a, NGO leh Transport Association-ah hemichungchang hi ngenna

te pek a ni. Mizoram chhunga check gate hrang hrang, AH & VETY, transport, police leh taxation-ah te dan lova ran phurh leh hrehawm taka phurh luh awm thin chu uluk leh zuala endikna kalpui tura ngen an ni.

7. The Mizoram Animal Control Act 2014-in a huam

bak ran leh ran inkar, mihring leh ran inkara harsatna thleng thin hi zirchian a, Animal law kan neih te tlawh chhana **Mizoram pum LC/VC hrang hrangten an hman tlan theih tura ran khuahkhirhna dan tha leh rualkhai zawk duang tura hmjakna kalpui a ni.**

AZOLLA I LO HMELHRIAT TAWH EM?

Ranvulhtu tena kan sum senso tamna ber chu ranchaw man hi a ni awm e. Mi thiamten an chhut dan chuan ranchaw manah hian kan senso zawng zawng aṭanga chhutin za zelah 60-70 vel hi ranchaw mana kan sen ral a ni. Hemi a nih avang hian kan ranvulh aṭanga hlawkna tam zawk kan dawn theih nan hma kan lak hi ranvulhtute tana thil pawimawh tawpkhawk a tling awm e. Chutih rual chuan kan senso tiziaawm tura kan thil tih tum pawh ngun tak leh ngaihtuahna seng chung si a, thil harsa lote kan ban thiam pawh a ṭul hle bawk a ni. Hemi chhanna nia lang chu kan sawi tum mek Azolla chin hi a ni awm e.

AZOLLA chu eng nge ni?

Azolla hi kâtchat chi khat, tuia ṭo ṭhin a ni a. Chakna leh ṭhatna tam tak a neih avangin ranchaw atan pawh thil ṭha leh ṭangkai tak a tling a ni. Leiṭha (Bio-fertilizer) atan buh chinna hmunah te hman lar ṭhin a ni bawk.

Azolla a thil awmte

Azolla hian chaw ṭha tam tak a pai a. Mi thiamte chhut danah chuan Protein 20-30% lai Azolla-ah hian a

awm a ni. Heng mai bakah hian essential amino-acids kan tih ho zawng zawng a kim bawka hriat a ni a. Tin, Vitamin lam, VitaminA & B12 ṭahnem tak a awm bakah heng mineral Calcium, Phosphorus, Potassium, Magnesium te hi a la pai tel cheu bawk a ni.

A chin dan

Azolla hi awlsam tea chin pun theih a ni a. Kan mamawh zat leh thar duh azirin ruahmanna siam

theih a ni a, ran neih zat azir pawhin a chinna tur kan ruahman thei bawk ang. Azolla hi tui a โต ที่thin a nih avangin tui tlin theihna kan neih a ๆul a. Hei hi cement-brick hmangin emaw, plastic sahar/silpauline hmangin kan remchan dan azirin siam mai tur a ni.

Ni tina 800Grams aṭanga 1Kg thar chhuah nan a chinna tur kha 6ft x 4ft siam a ngai a, chutah chuan tui chim chin 4 cm aia tlem dah loh tur a ni.

Mamawhte

1. Lei chunglāng (Sieved top soil) hrik fai: ḥin 2-3
2. Bawng ek tharlām: 2-3 Kg
3. Rock Phosphate/single super phosphate : 100-150 Grams
4. Azolla chi 100gram-500gram
5. Tui (inches 4 aia hniam lo tur a tlinnaah)
6. Ni hlim siamna tur remchang eng pawh (thosilen hlui, shade-net, rangva etc.)

A chunga tarlan tawh ang khian tui tlin theihna Feet 6-a sei feet 4-a zau (6ft x 4ft) kan siam phawt ang a. Lei chunglāng (top soil) hrik fai ḥin 2/3 vel kan chhung leh ang. Bawng ek tharlām kan lak kha tui nen kan hmet kawi ang a, a chaw nawi/hraw awm kan then fai hnuah kan chhung lut ve leh ang. Chuan Rock phosphate gram 100-150 vel kan telh leh ang a, tui chhung pahin kan thil dah te kan chawhpawl ḥtha vek ang. Uluk taka kan chawhpawl hnuah Azolla chi kan dah leh ang. Kan thar hma duh dan azirin a chi hi kan dah tam mai dawn a ni. ḥtha taka Azolla inthlahpung tur hian ni hlim (25-50% shade) an mamawh avangin a hlim kan siamsak a ๆul a, ran in bul hlim awmna remchang lai emaw thing hlim bulah pawh siam mai theih a ni bawk. Bawlhhlawh lut leh rannung lut tur lakah kan veng bawk tur a ni. Chuan

kar hniah dan velah bawng ek tharlâm 1kg leh phosphate gram100 enkawl zui zel nan kan pawlh thin ang a. Thla ruk (6 months) danah kan siam thar leh zel tur a ni. Kan Azolla thar chhuah kha a chi atan a hman leh zel thei a ni.

Eng tin nge/Eng zat nge kan ran kan pek ang?

Azolla hi a hringin emaw a roin a pek theih a. Kan ran vulh chi ar, vawk, bawng, kel etc. te tan chaw tha tak a ni a. A hringa pek mai hi a awlsam a, bawng ek rim te a lo nam thin avangin uluk taka sil kha a pawimawh a ni. Tin, Azolla kher lo pawh ranchaw eng

ang chi pawh vawi-lehkhatah kan ranten an hmelihriat hmain pek tam nghan vak loh tur a ni. Zawi zawia tih pun hret hret thin tur a ni. Ranin chaw tha a mamawh (concentrate feed) kan tih hi za zelah sawmnga (50%) lai Azolla hian a lo chhawk zangkhai thei a ni.

Azolla thatna

1. Chakna a pai hnem.
2. A chin a awlsam.
3. A inthlahpung chak (Biomass yield a sang)
4. A chinna senso a tlem.
5. A hring leh a roin a pek theih.
6. Dah that/ vawn that awlsam a ni.

Mizote hi ran ngaina leh ran vulh uar hnam kan ni a, ran kan vulh chhante hi inang lo tak tak an ni ngei ang. A then tan chuan eizawnna a ni a, a then chuan pet angin kan vulh a, a chhan chu a enga pawh ni se ranvulh hian mawhphruhnha chi hrang hrang a keng tel tih hi hre theuh ila. Chung mawhphurhna tam tak zingah chuan vaccine pek hi a pawimawh ber zinga mi chu a ni ngei ang. Vaccine pek kan tih hian natna lakah kan rante kan lo veng tihna mai a ni.

Kan ranvulhte hi mihring kan inenkawl uluk ang bawk hian enkawl ngai an ni ve a, nausen a lo pianga vaccine pek kan ngai pawimawh ang bawk hian kan ranvulhte pawh hian vaccine hi an mamawh ve a ni tih hi inhrilh nawn fo ila. Vaccine hi a tlangpuiin kum chanve emaw kum khat dana pek tur an ni a, kum khata vaccine vawi 2/1 lak nana kan insenna hi kan ranvulh an damloh palha kan sum, hun leh tha sen aiin a let

tam takin a tlem zawk a, chu mai bakah an damloh chuan chaw an thlah a, an taksa a lo chhia a, bawng phei chuan bawngchnute an pe chhuak tlem a, sa ei tlak lohah tam tak a chhuak a. Heng zawng zawng ngaihtuah chuan tihdam aiin inven a tha zawk tih hi a dikzia a lang chiang em em a ni.

Natna tam tak tan hian vaccine hi siam chhuah a la ni lo a, amaherawhchu kan hmuh theih leh awmsate tal hi chu a hun takah la hram

hram thei turin tan la thar ilo, chung vaccine kan hmuh phak leh pek theih langsar zualte chu lo sawi dawn ila.

1) VAWK VACCINE

i) Swine fever Vaccine : (Live I.P)

SF vaccination programme hi India ram pumah kalpui a ni a, tun hnaiah hmun thenkhatah te chuan la tha duh lo hi kan awm ta nual mai, CSF te chu a leng tak tak tawh lo kan ti a, ngaih kan ti tha em em ringawt mai thin hi chu ngaihtuah thui a ngai hle a ni. ASF a leng a, CSF vaccine lak a ngai lo ti pawl te kan awm thin, mahse, CSF hi a len tawh mang loh chhan chu vaccine kan pek that vang a ni a, vaccine kan lak duh loh chuan leng leh reng thei a ni tih hria ang u.

SF vaccine hi vawkte **thla 1 china upaah** pek tur a ni a (booster after 1 month), **thla 6 hnuah dose pangngaiin** pek leh tur a ni.

Vawk rai laiah chuan pek loh tur a ni.

ii) FMD Vaccine :

He vaccine hi **thla 2-a upa leh a chung lamah** hman tur a ni. **Thla 6 danah** pek thin tur a ni.

2) BAWNG VACCINE

i) FMD Vaccine: **(Raksha Ovac Trivalent)** **Inactivated**

FMD hi ran tam takin an vei thei a, Bawng, Kel leh Beramah chuan thla **4 leh a chung lama upaah** hman tur a ni. **He vaccine hian thla 6 chauh a ven avangin thla 6 danah** pek thin tur a ni. FMD vaccine hi FMD Eradication programme hnuah kalpui reng a ni.

ii) HS & BQ Vaccine : **Inactivated**

He vaccine hi Haemorrhagic Septiceamia leh Black Quarter venna atana Bawngah leh Lawia hman thin a ni. **Thla 6 leh a aia upaah hman tur a ni a, kum tin chiu tur a ni.**

iii) Bruvax : Strain 19 vaccine, Live

He vaccine hi Brucellosis natna venna atana Bawngah hman ṭhin a ni. **Bawngnote a nu thla 4 aṭanga thla 8-ah chauh pek tur.** Dose – 2ml s/c (single dose)

iv) LSD Vaccine :
