NOTIFICATION

In the interest of public service and in pursuance of the decision No 16 of the Council of Ministers in its meeting held on 18.06.2024, the Governor of Mizoram is pleased to allow non-functional promotion in respect of the members of Junior Grade, Senior Grade and Junior Administrative Grade of Mizoram Animal Husbandry & Veterinary Service (MAH & VS) to the Level-11, Level-12 and Level-13 of the Pay matrix as per the terms and conditions laid down below with immediate effect.

- 1) A member of the Mizoram Animal Husbandry & Veterinary Service (MAH & VS) who has rendered continuous service in the Junior Grade for a period of not less than 6(six) years shall be eligible for non-functional promotion to the Senior Grade of the MAH& VS in Level-11 of the pay matrix.
- 2) A member of the Mizoram Animal Husbandry & Veterinary Service (MAH & VS) who has rendered continuous service in the Senior Grade for a period of not less than 8 (eight) years shall be eligible for non-functional promotion to the Junior Administrative Grade of the MAH&VS in the Level-12 of the pay matrix.
- 3) A member of the Mizoram Animal Husbandry & Veterinary Service (MAH&VS) who has rendered continuous service for a period of not less than 18(eighteen) years from the date of entry into the duty post of MAH&VS shall be eligible for non-functional promotion to the Selection Grade of MAH&VS in Level-13 of the pay matrix.

Further, the composition of the Departmental Promotion Committee (DPC) constituted for the purpose of considering such promotions and the eligibility criteria therefore shall be identical to those prescribed for functional promotions.
