## 1. Introduction:

The Animal Husbandry & Veterinary dept delivers two main services viz animal health services and production enhancement. The two sector are inter-related and needs to be balanced. The department from time to time utilized fund available for establishment of veterinary institutions, however the demand is far to be med. Due to the recurring outbreaks of animal diseases such as PRRS, CSF and the introduction of the new lethal disease 'African Swine Fever Disease' possesses a serious threat to the farmers economy.

  - 7.1.** Screening of EOIs shall be carried out as per eligibility & Pre-qualification criteria mentioned in this document and based on verification of testimonials submitted.
  
  - 7.2.** The applicant meeting the requirements will be short listed for further consideration provided there are at least three qualified applicants.
  
  - 7.3.** Request for Proposal (RFP) will be issued to the shortlisted firms to seek their technical and financial proposals (in two bid system).
  
  - 7.4.** When the EOI is responded by 10 or more firms, the following criteria with their respective weightage shall be followed for shortlisting. The benchmark will be a score of 50%.

**9. Condition under which EOI is issued:** The EOI is not an offer and is issued with no commitment. Department reserves the right to withdraw EOI and or vary part thereof at any stage. The Department further reserves the right to disqualify any bidder, should it be necessary at any stage.

**10. Conflict of Interest:** Where there is any indication that a conflict of interest exists or may arise, it shall be the responsibility of the bidder/ agency to inform the department detailing the conflict in writing as an attachment to this document. Department will be the final arbiter in cases of potential conflicts of interest. Failure to notify the department of any potential conflict of interest will invalidate any verbal or written agreement.

**11. Force Majeure:** Any circumstances beyond the control of the selected agency/ agents/ partner or Government Department as the case may be which cannot be foreseen and which substantially affect the performance shall be dealt with conducive atmosphere.

Any legal dispute litigation arising out of the terms, the Court of Law at Aizawl shall have the Jurisdiction to adjudicate the same.

**12.Code of Integrity for Procuring Authority & Bidders:** Code of Integrity and penalties for violating the Govt of India, Ministry of Finance, Department of Expenditure shall apply to this REOI process.
