Mi thiamten an chhut danin ‘Ber’ thla kan chuang kai china ruah tui tla an chhut dan chuan Mizorama ruah tui tlak tam ber kum a pha der tawh an ti a, hei hian a ken tel chu ruah tui khawl tur kan ngah rualin lei min leh kawng chhia a tam thu a ni. Hetianga ram pum kan buai lai hian keini ranvultute pawhin kan hma zawnah harsatna neuh neuh kan tawk ve reng thin a, ran chaw State pawn atanga a tam zawk chaw lut thin kan nih angin kawng chhiat vangin ran chaw lei mai tur a van lai te a awm a, ran hriselna kawngah pawh ASF-in min kiansan thei meuh lo a, September 2024 thla tawp thlengin vawk 22,626 zet suat a ni a, 13,418 an thi tawh bawk a ni. Hei hian vawk vulhtuteah nasa takin harsatna a thlen a, sorkar tan pawh hma thar han lak vak ngaihna a awm rih lo. Kumtluan maia fur ang thala ruah a tlak takah chuan ranvultute tana harsatna a tlen thin tam tak zinga kan hmaih miah lo tur chu ran chaw dah that dan chungchang a ni a, a bik takin bawng, vawk leh ar tam tham deuh vulhte chuan ran chaw a bag-a khawl leh dah that a ngai thin a, mahse, khua a lo chhiat rei deuh a, ran chaw dahna hmunin ni a hmuh that loh rei chuan ran chaw bag-a dah te a lo hmuar thin a, ran te ei tlak lohin a awmin sum tam tak a chan theih a ni. Department-a hotu nihna hnuaih Arunachal hnuaih kan Doctor panga kan sawi tawhte bakah Assam sawrkar hnuaih thawk lai Dr. Zokhuma, Dr. Rohmingthanga, Dr. Lalhnuna, Dr. Lianmawia, Dr. Chalruala, Dr. Chetia, Dr. PK Nath te an ni a. Kum 1973 tawp dawnah Dr. BC Thanthuama'n a zawm ve leh a, kum 1974 – laihawlah Dr. Sangzuala'n a zawm ve leh bawk.

Kan hotu hmasate kha an lo fakawm hle mai. Kan hmun hma Zoram dung tluan, Vairengte aṭanga Saiha thleng; Champhai aṭanga Mamit te hi an hun lai aṭanga hawn leh neih a

ni. Theih ang angin ran chi tha kan neih nân farm an siam a, Hospital, Dispensary, RAH Centre an din. Kum 1978-a hna kan zawm hlim leh a hnu deuh thleng khan Electric supply te Aizawl-ah takngial pawh a chhe hle. Aizawl Electric Veng, tûna an E-in-C office awmnaah hian Diesel Engine generation hmanga êng pek chhuah a ni a, hetiang hi Lunglei-ah pawh a awm a, chung chu power supply na hnâr niin, a bunna hmun pawh Electric Veng tih a ni. Tunlai miten a hming put chhan bulbal hre tak maw. Aizawla mi MNA-in an bomb chhiat pawh khan rei tak Aizawl-ah current a awm lo. Hetiang power supply chhe chung hian, kei pawhin 1978-a hna ka zawm hlima ka hman

Fridge Vety Dispensary-ah khan, vaccine vawn ɬhatna chu kerosene/khawnvartui hmanga bati, phita nei hâl/chhita, khamia fridge a (ammonia/chlorofluoro-carbon) evaporate/liquify turin kha bati kha a tui/khawnvartui thun khah reng a ni a, chhun zan zawma baltin tui khaina tur te, vawk chaw suahna tur aluminium fianpui te department-in phû (deserving) nia a hriat te hnенah a sem a. Heng hi miin an hlut a, department-in a lar phah a, officer/doctor-te pawhin office lamah leh in lamah in lêng an ngah. Saiha D.V.O phei chuan, “tum khat chu vawkte subsidy dawng turin Kêl ka quarter-ah min rawn pe,” a tih ka la hria.

Chuvangin Department pawh hi tun laiah “Live-stock Rearing Family Oriented” ranvulhtute hamɬhatna lam hawi zawnga, “TUN HMA DEUH” a kal dan khan,

hma kan sawn nan kal a tul hmêl.

TÛN: Tunah chuan le, hei Mizo pawh veterinary profession-ah kan ɬahnem ve ta. Thiam bikna sang tak neih lah an tam ta. Hmanrua leh building te pawh changkâng tak, computer nêñ a thawh ngai te nen thuam an lo ni ta. Doctor dinhmun pawh zahawmin, hlawh pawh deptt. tam zawka officer te hlawh aiin a tha ta. Kaisan chak thuah erawh duh ang a ni lo mai thei. Tun laiah deptt. dang officer te pawh inhawh tawt tawngkhawng (stagnation)-na a nasa ve tho a ni a. Dr. Zokhuma sawi ka hriat reng chu, “Hnathawh châkin tum viau mah ila, kan hun lai khan a tih tak tak theih loh a, beidawn chang ka nei rûm rûm a, mahse, nikhua a lo rei a, kan han kaisan ve takah chuan a lawmawm ve tho mai” a ti ɬhin.

Tunah vawk pul hri te an lo len hian, vawk thi zat

lo tamzia te, mi malin vawk vulhna lian tham te an lo nei thluah tawh mai a. Vawk pûl hri (ASF) vânga vawk thi hlutna pawh cheng vaibelchhe tel meuh hu a ni tihte kan hria a. A ropui rualin, a rilru nat thlak hle mai. A department ang leh a profession ang pawhin ɻan lak a ngai hle. Han ɻang leh zual teh u.

Tûn hunah chuan Veterinary Doctor pawh kan lo ɻahnem ta. A thawk lai leh degree zo tawh, sawrkar-a la lut lo leh Post Graduate zirlaite nena belkhawm vek phei chuan “inpang aw inzial”, mup mup tham kan awm tawh a. Hei hian a entir chu Veterinary Profession hi Profession zahawm, zirtlak, zir tham a ni tih a lang a, a lawmawm hle. Keimahni tualzawl ngeiah pawh a zirna college kan nei ta. Heta lut tur ringawt pawh hian thiam fe nih bakah, “Gauhati-a kan zir ve lai a, cinema film ɻha Sunday

morning show en tûra ticket chan tuma kan inchuh te kha a ang tawh.” Kan inchuh dan kawng erawh a dang. Zirna sang zawk Post Graduate, Ph.D degree nei an kat nuk tawh bawk nêñ, a lawmawm e. Hêng mi thiamte leh hman-raw ɻha awm zelte nen hian hmasawnna duhawm leh chak zawk ‘tûn hunah’ hian min thlen se.

TÛN HNU: Tûn hnu atana ɻan kan lak loh chuan Mizoramah ran hri lengte kan ven hneh loh chuan ranvulh, a bikin vawk vulh lamah hmasawn a har ngawt ang. Sawi vek sen a ni lo ang a, Bawng lian (Dairy Cattle) mawlh mai hi a tlem tulh tulh a, tual chhung thar bawng hnutte hi kan nei lo thuai mai ang tih a hlauhawm. A chhan nia lang chu bawng chaw (concentrate wheat bran) a to sawt a, hnimhnah hring/hay duh ang pek tûr a harsa. Mizoram-ah ran vulha eizawng an tam hma

chuan Vety Doctor leh a profession hlutnain hma a sawn thei lo ang, mipui zinga min mamawhtu an tam loh chuan sawrkarah leh mipuiah kan bûk a rit thei lo. Private Veterinary Hospital/Clinic-ah te hma kan sawn a, mi hriat kan hlawh a, a lawmawm. Hengte erawh mi nâwlpuiaia changkangte hmakhua a ni deuh. Mizoram-ah chhungkua singkhat emaw a sang bi talin ran vulh eizawn nân a an hman tak tak hma chuan kan hlutnain, hlutna a nei tlem zel ang. ‘TÛN HNU’ zel atan man han la sauh sauh teh u. Kan ram leh hnam, kan profession tân aw.

Mizoram Union Territory a nih hlim khan Development Commission atan Pu Gurunga (India Frontier Administrative Service niin ka hria) India sawrkarin a rawn dah a. Kum 1973-a B.V.Sc & A.H.zir tura ka interview pawh khan Chairman a ni nghe

nghe. Ani kha Gurkhali hnam, bawngchnute nghei thei vak lo kha ni awm a ni. Khatia Aizawl-a a rawn awm khan, bawngchnute ɻeka (lâk) tur a zawng a, khatih hun lai khan a hmu lo a ni awm e. Aizawl leh a chhehvela Bawng lian vulh an awm theih nan Dairy Cow Subsidy Scheme awm theih dan a ngaihtuah a. Heta ɻang hian Durtlang leh Sihphir velah Bawng lianhnute tam chi Mizoramah vulh man a lo ni ta, tih thu hi Dr. Zokhuma min hrilh dan ka hriat reng a ni. Tunah chuan Durtlang leh Sihphir dairy pocket kan lo tih ve ɻhin na khua leh vêng-ah pawh Bawnglian (Dairy Cow) a kum telin an tlem zel a. TÛN HNU hun lo awm zêl tûrah phei chuan an rem zo ang tih hlauhawm khawp a ni. Kan mi thiam leh kan hmanraw ɻha neihte hmang ɻangkai turin kan ramah ran vulh kan neih tam a ngai, kan huhâng mipuiah leh

sawrkarah a nat theih nan. Tûn hnu lo awm zel turah Department hian inrêlbawlna changtlung (infrastructure) lama hmasâwnna a pawimawh rualin, ran kan vulh tam theihna tûr lamah man lak zual a ngai hle a ni.

Awle, pensioner-te han nih tawh chuan, "TÛN HNU-a he profession leh kan Department ̄han zêl nan hian tih theih kan nei tawh lo a. Mahse, kan la men ve diar diar chhûng erawh hi chuan 'til lâk thil thlirin' kan thlir mai mai theih chauh tawh che u a ni. Achievement (chhuantlak hlawhtlinna) he profession ah leh Department-a awmte hian, mahni awm hmunah tu mah dang

hriatpui loh hian kan lo lawm ve ̄thin. A hmâwr bâwk nân kan tih theih ang tawka tih tak meuha he profession leh a Department tân a ka lo thawh vena", kan naute'n min la hriatpui ve na-ah, mimal takin in chungah ka lawm hle a ni.

Mihringte kan eileh inte zinga chakna min petu chaw pawimawhte zinga mi chu sa leh artui hi kan ti thei awm e. Sa dangte nen kan khaikhin phei chuan arsa hi a hrisel hle a, mizote pawh hian kan ei uar ve ta hle mai. Arsa leh artui kan ei tam zawk erawh hi chu State dang atanga kan lak luh ala ni rih a. Arsa leh artui ah kan la intodelh lo hle a, kan ram economy a hniam hle laiin kan sum uihawm tham tak kumtin state dangah heng ar leh artui kan lakluh atang hian a luangchhuak nasa hle a ni. Kan economy siam that nan ar leh artui a kan intodelh hi a pawimawh takzet a ni.

ICMR (Indian Council of Medical Research) in a ruahman dana mi pakhat tan kumkhat chhung artui a mamawh zat chu pum

180 a ni. Ar vulh dan pawimawh tak tak chi hnih ah lo lut hmasa ila, chung te chu:

- 1) Thingtlang ar vulh (Backyard Farming) leh
- 2) Tam tham a arvulh (Commercial Farming) te an ni.

(1) **Thingtlang ar vulh (Backyard Farming)**

Thingtlang ar vulh dan hi ar vulh lama thanna nasa tak hian a zuankhum a tihttheih awm e. Chutih laiin tual arsa leh a tui te hi a man lamah anla hlu zawk reng a ni. A chhan chu tha zawk leh tuizawk a ngaih annih tlat vang a ni. Thingtlang arvulh backyard poultry farming chungchang leh a pawimawhna lo tarlang ila. Backyard farming ang chi a ar hi pi pu te atanga anlo chin than tawh a ni a,

hetiang ah hian ar panga atanga ar sawmhnih vel tual ar emaw, a chi tha zawk siamchhuah emaw, mahni eiral leh pawisa tlem a zawng lakluh nana vulh a ni. Hmeichhia leh naupang ten an hna pangai thawk pahin ar hi an vulh deuh ber a ni. Hetianga ar vulh ah hian zanah inchhungah dahin chhun lamah an flattir mai thin a. An mahni a chaw an zawn mai bakah zing leh tlaiah buhhum veikhat vel lek pe in chaw an pe ve mai thin a ni. Chutiangah chuan chaw pek bik neih a ngai lemlo a. Amaherawh chu tlema han duat deuhin an than a thatphah a, an damthat phah bakah an tui pawh a tam phah ve thin a ni. Dan naran in tual ar emaw, ar chi bik emaw hetianga tana vulh chi bik siamchhuah te hi India ram hmun dangah chuan an uar em em a ni.

Thingtlang ar vulh uar chhoh zelna hian eitha hmuhna kawng mai bakah sum hmuhna engemaw chen chu a chawikang

dawn a ni. Hei vang hian backyard poultry farming atanga arsa leh artui tihpun hi India sawrkar chuan kum tam tak chhung enghelh ah alo nei tawh a. Chumi atan chuan backyard poultry tihhmasawnna turin programme hrang hrang a siam bawk a ni. Chung atang chuan ar breed thar tha tak tak an siam chhuak a chungte chu Giriraja, Debendra, Gramapriya, Krishna-J, Swarnadhar, Vanaraja leh a dang te an ni. Backyard farming hi organic farming chi khat, artui leh arsa a thil tha lo (chemical) awm loh na a ni. Hei hi leilung sik leh sa tibuai lo a ar vulh dan kawng a ni. Chu bakah hei hi rannung chimawm ho tihrem nan te, lei tha siam nan te a pawimawh hle a ni. Backyard farming pawimawhna chhan chu ; Hun rei lote chhunga sum siamna a ni a. A tira senso a tlem a, a vulh dan a awlsam a, thingtlang killkhawr ah pawh artui leh arsa a awm phah thei a ni. Tual ar an

nih deuh ber avangin an dam tha a, natna leh eiraltu lak ah an him bik a ni.

Thingtlang mi khawsak harsa zawk tan a vulhna kawng ah mamawh a tlem avangin an tan vulh awm chi tak a ni. Hetianga ar vulh hi India, Bangladesh leh ram thenkhatah an la uar hle a. Hetiang ah hian ar te chu hmun te deuh leh lian deuh hlekah te hung chhungah vulh an ni thin a. Chhun lamah chaw zawngin an vak chhuak a, chutiang chuan tampuia vulh (commercial system) angin hmun khatah dahkhawm reng an ni lova, zana an tawm himna tur erawh siamsak an ni choh a ni. Chutiang ah chuan an chaw tur bik ruatsak theih an ni lo a, an mahnia an chaw hmuuhbelh nan lek buhhum veikhat vel zing leh tlai ah an pe mai thin. Ar rual ho chu chi hlang ni mahse anu leh apa leh upat dan inanglo thluah awmkhawm an ni ber a. A tui tam leh than that lamah chuan pawna chhuah tawp

ai chuan tlema ngaihsak theih an nih avangin an tha zawk a ni, mahni tharchhuah arsa leh artui ngei ei theih a nihna hi a vulhtu tana chhenfakawm nihna chu a ni. Eibang pah mai tur te choka hnawm-hnawk te a chawm mai theih an nih bawk avang te hian vulh an nawm phah ve bawk a ni.

Ar tlat chhuah tir tawp (free range poultry) te aia hlawk zawka vulh an nih theih nan kan han sawilan tawh te ang breed ho hi vulh ila hetiang arte hi an thar hlawk bakah an tlat chhuah tir theih tho bawk si a chuvangin, in tha zawk leh ei tur tha zawk pe ila natna avanga an thih tlem nan hri venna leh damdawi pe mumal bawka, free range system a arvulh hi Africa leh Latin Americaah te a lar hle a ni. Hetianga ar vulh hi thingtlang lamah chauh hmuuh a ni a, khawpui lam deuhah chuan Commercial Poultry kan tih ang chi tam tham a ar vulh hi ani tlangpui.

**(2) Ar tam thama vulh
(Commercial Farming)**

A dawt leh ah chuan tam thama ar vulh kan tih angchi hi commercial broiler leh layer vulh chungchang lo sawi leh ta ila; Hetiang ang a ar farm lian hlawhtling taka siam tur chuan thil tam tak tih tur a awm a. A zawng zawng chuan kan sawi zo hman lovang a, chuvangin chung tihtur zingah chuan ar hriselna lam venna kawnga hmalakna kawng hrang hrang kan sawi dawn a ni. Chungte chu:

(i) Ar hrisel leh ar damlo thliar hran chungchang – Ar farm ah hian ar hriselna hi hlawkna nei tur chuan a pawimawh ber a ni. Ar pakhat lek emaw tlem pawh lo damlo se hriatchhuah vat an nih loh chuan, ar rual zinga natna inkai darh vanga thih puk na a thleng thei.

(ii) Ar in silfai, damdawi hmanga natna hrik thenfai leh ur thianghlim chungchang; In vawnfai na,

damdawi hmanga natna hrik thenfai leh damdawi hmanga ur thianghlim te zawm that tur a ni.

(iii) Hmarua silfai leh damdawi hmanga tih thianghlim chungchang – Hmanraw hrang hrangte, damdawi hmanga tih thianghlim te ar in tih thianghlim te hi thil pawimawh tak a ni a. Heng hmanrua te ah hian natna hrik te an lo awm thei a, hetiang natna hrik awmna hmanrua kan hman hian ar hriselah te natna a thlen thei a, chuvangin kan hmanrawn hman ti fai thin tur a ni.

(iv) Ar vulh te tana tui pawlh damdawi leh tui tihtianghlim chungchang – Tui hmanga damdawi pek hi natna hri venna leh damlo enkawl nan a tangkai em em a ni. Tuia natna hrik awmsa tihbo nan, tui thianghlim pek ngei ngei tur an ni.

(v) Ar natna ven kawnga hmalak chungchang – He hmalakna hian kawng

hrang hrang a huam a. Farm a hnathawk tu te tana thawmhnhaw bik buatsaih te, farm luh hmaa inbualfai leh thawmhnhaw thlak te a huam a. Farm chhunga pawn lam mi luh phalloh te, ram sava tihbo leh a bul vela ar vulh khap te, ke chiahna 5% phenol siam te, farm chhung a hmanlai hmanraw hrang hrang fai taka vawn te leh uluk taka ar thi sengbo te a huam a ni. Hemikawng a hmalakna reng reng chu senso tlem thei ang ber ni thei se, chutih rualin natna ven leh a dark tur ven kawngah kawngro su tak ni thei se a tha hle ang.

(vi) Ar hri venna vaccine pek chungchang – Tunlaiah natna tam tak veng thei vaccine te siam chhuah a lo ni leh zel a. Chuvangin, a nihna tur ang taka pek an nih chuan natna tam tak lakah a veng thei a ni. Natna an neih loh chuan an thawhchhuah pawh a tam nge nge a ni.

(vii) Ar thi, ar damlo leh taksa peng dangte endik leh zirchian atana buatsaih chungchang – Heng kan sawi te hi ar natna zirchian nan uluk takin laboratory ah thawn tur a ni.

(viii) Ar thi, ar damlo leh bawlhlawh dangte senghawi chungchang – Hetah hian hautak silo leh boruak ti bawlhlawh si lova senghawi theih nise, a duhawm hle ang.

Heng kan tarlan te bakah hian thil pawimawh hriattur tam tak a awm a, farm siam dawn a ruahmanna mumal neih te , farm tana ziaka chhin-chhiahna vawnthat te, farm economics bulpui a tih dan leh tharchuah dan phung duan chhuah te, tharchhuah senso tihtlem dan kawng hrang hrang te leh arvulh dinhmun chawisan theihdan tur kawng te kan hrechiang tur a ni.

He thumal “Zoonoses” tih hi German Scientist hmingthang tak Rudolf Virchow an kum 1880 a a phuah a ni.

6th July hi World Zoonoses Day a ni a, khawvel hmun hrang hrangah he ni hi urhsun takin hman thin a ni a. Kumin 2024 World Zoonoses Day thupui (Theme) chu *“Preventing the spread of Zoonotic Diseases”* tih a ni a, a

awmzia chu ran leh mihring inkara natna inkaichhawn theih laka invenhimna a tul zia in zirtira ni. Tichuan Zoonotic diseases kan tih chuan natna reng reng ran leh mihring inkara inkaichhawn theih ho te kha “Zoonotic diseases” tiin kan sawi a ni. Zoonotic diseases inkaichhawn theih dan kawng hrang hrang te chu:

Eg. *Amoebiasis, giardiasis, shigellosis*

3. Ka emaw hnar atanga hip luh (Inhalation):

1. Uluk taka kut sil fai thin: Kan kut te hi uluk takin kan silfai reng tur a ni a, a bikin ran kawih zighthah te, eitur khawih dawnte, eirawngbawl dawn te, zun leh ek thiaw zighthah te leh naute leh damlo diaper thlak zighthah te hian fai takin kut kan sil thin tur a ni.

2. Vector Control: Vector kan tih mai entirnan thosi, tho, saphihrik leh a dangte lakah kan inveng fimkhur thin tur a ni a, kan in leh a chhehvelte kan vawngfai thin tur a ni. A chhan chu heng vector te hi natna hrik (bacteria, virus, parasites etc) nasa taka pu dark thintu te an nih avangin.



1. Khur thuk taka laih tur.
2. Chinai in vawk ruang phul/leih leh tur.
3. Leivunga chhilh leh hnu ah – a chunglangah chinai bawkin khuh leh tur.
4. A ruang sawngbawltu in shoe cover leh gloves a bun tur a ni.
5. Shoe cover leh gloves te hi khur chhunga phum tel tur. Chumi hnu ah kut fai taka sil tur a ni.
6. Ruang phurhna motor emaw ruang zawnna hmanrua disinfectant or sahbon a tihfai thin tur.
7. Disinfectant hman tur te:
 - a) 2% Calcium Hydroxide (Chinai)
 - b) 2% Sodium Hydroxide (Caustic Soda)
 - c) Detergent (Sahbon – Surf, Mr White, Tide etc...)
 - d) Phenol Substitute.
 - e) 2-3% Sodium or Calcium Hypochlorite (bleach leh bleaching powder)
 - f) Iodine Compounds.
