

National Livestock Mission

Objectives

1.

Employment generation through entrepreneurship development in small ruminant, poultry and piggery sector & the fodder sector.

2.

Increase of per animal productivity through breed improvement.

3.

Increase in production of meat, eggs, goat milk, wool and fodder.

4.

Increasing availability of fodder and feed to substantially meet the demand – through strengthening the fodder seed supply chain and availability of certified fodder seeds.

5.

Encouraging establishment of fodder processing units to reduce the demand supply gap.

6.

Promoting risk management measures including livestock insurance for farmers.

7.

Promoting applied research in prioritized areas of poultry, sheep, goat, feed and fodder.

8.

Capacity building of state functionaries and livestock owners through strengthened extension machinery to provide quality extension services to farmers.

9.

Promoting skill based training and dissemination of technologies for reducing cost of production and improving production in the livestock sector.



Sub-Mission on Breed Development of Livestock and Poultry

Mission Design

The re-aligned Mission will have three Sub-Missions

Sub-Mission on Feed and Fodder Development

Sub-Mission on Innovation and Extension

Aims to incentivize Institutes, Universities and Organizations carrying out research and development related to sheep, goats, pigs and the feed & fodder sector, extension activities, livestock insurance and innovation.



Eligible Entities

Individuals, Self Help Groups (SHGs), Farmer Producer Organizations (FPOs), Farmer Cooperative Organizations (FCOs), Joint Liability Groups (JLGs) and Section 8 Companies

Selection Criteria

Trained Entrepreneur or employing Trained Experts for running the project

Loan Sanctioned or Bank Guarantee in Self-financed projects

Own Land or Leased Land

Relevant Documents for KYC

Entrepreneurs for Breed Development in Rural Poultry

Activities Supported : For establishment of a Parent farm, Rural Hatchery, Brooder-cum-Mother Unit for hatching eggs and chicks, for rearing chicks upto four weeks in the Mother Unit (with minimum 1000 parent layers).

Financial Assistance Available : Rs. 25 lac



Entrepreneurs for Breed Development in small ruminant sector (Sheep and Goat farming)

Activities Supported : For establishment of a Sheep and Goat Breeding Unit.

Financial Assistance Available : Rs. 50 lac



Promotion of Piggery Entrepreneurs

Activities Supported : For setting up a Breeder Farm with a minimum of 100 Sows and 10 Boars, breeding animals sourced from Central or State Government / University farms or local farmers with high genetic merit.

Financial Assistance Available : Rs. 30 lac



Entrepreneurship in Feed and Fodder

Activities Supported : For setting up a Fodder Value Addition Unit for Hay / Silage / Total Mixed Ration (TMR) preparation, Fodder Block making or Storage facilities for Fodder.

Financial Assistance Available : Rs. 50 lac



Note for all the above schemes :

50% capital subsidy up to the subsidy limit will be remitted directly to the Beneficiary account through Small Industries Development Bank of India (SIDBI) in two equal installments.
