BACKGROUND OF THE PROJECT:

This project is implemented to bring about a standard standing of quality chicks and egg for production in the Southern part of Mizoram, control to check the volatile fluctuation of price rates regarding various poultry and poultry by-products which was mainly controlled and governed by middlemen importing poultry and poultry by-products from the neighbouring states. Presently the Indbro Hatchery Farm has a capacity of hatching 57600 eggs per incubation. However, the farm could utilized only half of its hatching capability due to limited production of hatching eggs since the farm has only 2 layer sheds with a capacity of housing 3000 layers and 1128 layers. Optimal utilisation of the present machinery can only be fulfilled through addition of infrastructure for egg production such as construction of at least 2 layer houses, 2 grower houses and 1 brooder houses.

The project will also help in commercialization of states owned poultry and poultry by-products thereby contributing a great factor to the increasing state economy and thereby boosting availability of quality poultry and poultry products at southern part of Mizoram.

To bring a uniform distribution of poultry and poultry product it is propose to establish a poultry farm exclusively for Lunglei district of 5000 nos of live bird capacity to cater the needs covering Lunglei, Lawngtlai and Saiha in particular to supply of Day Old Chicks and Brooded chicks

<u>SCOPE OF TENDER:</u> Open tender for supply of Prefabricated Poultry House and Equipments.

<u>TENDER AMOUNT:</u> Rs. **3,94,05,080.00** (Rupees Three Crores Ninety Four Lakhs Five Thousand and Eighty) only.

KEY REQUIREMENT OF THE BID:

- 1. The Government Department may terminate the Tender at any time and without assigning any reason.
- 2. The Government Department makes no commitments, express or implied, that this process will result in business transaction with anyone.
- 3. The bidder's participate in this process will result the Government Department selecting the bidder to engage towards execution of the contract.

TENDER FEE:

The Tender document can be procured with a non-refunable demand draft of Rs. 2000.00 per bid drawn in favour of Director, Animal Husbandry and Veterinary, Mizoram from any Nationalized Bank payable at Aizawl, Mizoram upto 25th April 2018 upto 12:00PM and will be open on the same date at 2:00PM from the undersigned or can be downloaded at the Department's website.

EARNEST MONEY:

- 1) Bidders shall submit, EMD of 4 % of their respective financial bid in the form of Demand Draft issued by any nationalized Bank in favour of *"Director. Animal Husbandry & Veterinary, Aizawl, Mizoram"* payable at Aizawl, and should be valid for 3 months from the date of Tender.
- 2) EMD of unsuccessful bidders would be refunded within 1 month from the selection of successful bidder, without accruing any interest.
- 3) The Tender without EMD will be summarily rejected.
- 4) The EMD may be forfeited:
 - a) if a bidder withdraws its bid during the bid validity.
 - b) in case of a successful bidder fails to sign contract agreement or provide performance guarantee.

SUBMISSION OF TENDER:

- 1) Request of additions, alterations, notifications, correction etc. of both terms and conditions or rates after opting of the tender will not be considered.
- 2) The bidder shall have eligibility qualification details, relevant certificates, documents in support of their eligibility. All supporting documents should be stamped and signed.

3) Each Bid shall be submitted in Two Envelope system, one for Technical Bid and the other for Financial Bid. The Envelope shall be submitted in a clearly addressing the Director. Other terms and condition shall stands the same.

CRITERIA FOR EVALUATION:

- 1. Technical Eligibility : Bidder can be a firm, organisation, company, registered society incorporated in India – Certified letter by authorized signatory in the field of Pre-Fabricated Poultry Houses with Equipments
- 2. Technical Capacity : The bidder should have an experienced expertise in Poultry House technologies or an experienced hand (Manpower) involving in installation and erection of prefab poultry houses.

The bidder should be aware of turnkey basis involving supply, build & tendered a technical knowhow. Certificates wherever applicable in support and an agreement of Turnkey Basis should be submitted in the Technical Bid.

- 3. Local Service : The Tenderer should have an Office in near Convenient proximity for easy access with sufficient Personnel hands.
- 4. Certificate of : To be submitted in the Technical Bid Company, registration, Valid Sale Tax

FINANCIAL BID:

The Financial Bids of Technically Qualified Bidder shall be only eligible for the Financial Bid.

The Bid Price will include all taxes, charges etc. in Indian Rupees and cannot be revised upward at any cost.

Lowest Commercial/Financial Bid (L_1) shall be considered, however, this shall not bind the selection of Bidder for award of works.
